**MINUTES OF THE BOARD OF EDUCATION  
April 25, 2016**

The regular meeting of the Cass City Public School Board of Education was called to order on April 26, 2016 at 7:00 p.m., in the Cass City High School Library by President Alice Zaleski.

Behavioral Coach Nick Moyer gave a presentation on a new program at the Jr/Sr High School to help with at risk students with behavioral problems. He has 15 students that he is working with right now. He is helping them get caught up in school, raising their grades, attending school more regularly and helping to deal with anger issues in a more appropriate way and keeping in contact with their parents.

**Reports and Communications:**

CFO Allison Zimba asked the board to make a decision on whether or not to offer a Voluntary Separation Incentive Agreement. The board discussed the issue and decided not to offer an agreement this year. She also notified the board that she would be sending budget scenarios for the 2016-2017 budget to them for them to review before the May board meeting. She asked for the board to adopt a resolution for the interest rate on the Honeywell project to be lowered from 4.15% to 3.00%. Secretary Janie Meeker read the resolution. Superintendent Hartel updated the board on information regarding the November 8<sup>th</sup> election. If their term is up this year the deadline is July 26<sup>th</sup> to turn in paperwork to Ed Labelle.

It was moved by Janie Meeker, supported by Craig Bellew, that the resignation from Bus Mechanic Rod Mazure be accepted with regrets. **All Ayes. MOTION CARRIED.** (A copy of the letter is in the Secretary's book)

Mr. Hartel let the board know that Friday, May 27<sup>th</sup>, will remain a half day of school and that the Jr/Sr High School will be adding 2 minutes to the beginning and 2 minutes to the end of their day beginning April 26<sup>th</sup> to get in the required hours by the state. The Elementary school has enough buffer hours that they do not need to increase their minutes.

A resolution was read by Janie Meeker regarding the use of unmanned aerial vehicles (UAV's) being prohibited on school grounds when there are students and spectators present.
