Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2017-18 educational progress for Cass City Jr./Sr. High School. For the 2017-18 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

* Note TSI and ATS definitions were changed for the 2018-19 school year per federal requirements. The new definitions are:

TSI – The school has at least one subgroup performing in the bottom 25% within each applicable accountability index component.

ATS – The school has met the criteria for TSI identification and has at least one subgroup performing at the same level as a CSI school.

One of the key challenges facing schools is the availability of consistent, timely and reliable data to help chart student growth. Currently there is a change over to MSTEP and SAT testing which is still in its infancy. Until we have 3 or more years of this data to compare, it is difficult to get a gauge of where you are at. However, in the meantime, we are focusing our efforts into utilizing AIMSWEB, Khan Academy as well as a couple of other local assessments to assist in filling in the gaps until that data is available.

State law requires that we also report additional information.

-Students who live in the district and have been identified as 7-12 graders are eligible to be assigned to Cass City Jr./Sr. High School. Cass City Schools does participate in Schools of Choice for grades 7-10.

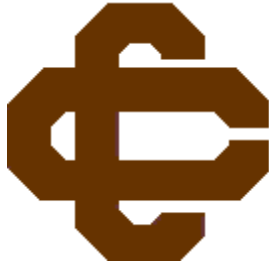
